# C) QUALIFICATIONS PRESCRIBED FOR THE POST OF ASSISTANTPROFESSOR:

- i) Good academic record with at least 55% marks (or an equivalent grade in a point Scale wherever grading system is followed) at the Master's Degree level in concernedSubject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii) NET shall be the compulsory requirement for those with Post-Graduate Degrees only. But, in respect of candidates who belong to J&K State and are not NET qualified, SET shall be the compulsory requirement.
- iii) The candidates without NET or SET having Ph.D. Degree in the concerned subject in compliance of the **UGC (Minimum Standards and Procedure for award of Ph.D.Degree) Regulations, 2009,** with amendments from time to time shall be exempted from the requirement of minimum eligibility conditions of NET/SET.
- iv) A relaxation of 5% in marks shall be provided at the Master's level for the scheduled caste / scheduled tribe / Differently- abled)/ other Backward classes (OBC) categories for the purpose of eligibility.

**D)** Besides fulfilling conditions (ii), (iii) and (iv) of eligibility specified above at **'C'**, the qualifications for the following posts shall be as under:-

#### a. For the Post of Assistant Professor in Disaster Management:

i) A Master's Degree in Disaster Management /Geography/ Geology/ Env. Science with at least 55% marks (orequivalent grade in a point scale wherever grading system is followed).

# b. For the Post of Assistant Professor in Renewable Energy:

M.Tech / M.E through GATE/ Ph.D in Electrical / Mechanical / Electronics / Chemical Engineering, with specialization in Renewable Energy from an Indian University, or an equivalent degree from an accredited foreign University having good academic record with, at least, First class at Masters level (or an equivalent grade in a point scale wherever grading system is followed).

Note: Candidates holding Ph.D degree in the above branches of Engineering in accordance with UGC regulations shall be preferred.

# c. For the Post of Assistant Professor in Tourism & Heritage Management:

Master's Degree in Tourism Management / Tourism and Travel Management with specialization in Heritage Management from an Indian University, or anequivalent degree from an accredited foreign Universityhaving Good academic record with at least 55% marks (or an equivalent grade in a point scalewherever grading system is followed).

#### E) PERCENTAGE EQUIVALENCE OF GRADE POINTS FOR A SEVEN POINTS SCALE:

In the Seven Point Scale with letter grades O, A, B, C, D, E & F, "B" shall be regarded asequivalent of 55%, wherever the grading system is followed:

#### F) SHORTLISTING OF CANDIDATES

# I) OTHER CONDITIONS:

- i) Eligibility of candidates shall be determined in terms of the relevant UGC Regulations read together with amendments from time to time that may come in force for the purpose.
- ii) Candidate seeking exemption from NET/SLET/SET are required to produce a bona-fide certificate from the concerned University to the effect that the said candidate has been awarded Ph.D. degree in conformity with the **UGC** (**Minimum Standards and Procedure for award of Ph.D Degree**) **Regulations, 2009**, with amendments issued from time to time.
- iii) Candidates with Ph.D degree having passed their Master's Degree prior to 19th
- September, 1991 having secured 50% or more marks in the Master's Degree Examination shall also be eligible to apply for the post of Assistant Professor.
- iv) NET/SLET/SET shall not be required for such Master's Degree Programmes in disciplines for which NET/SLET/SET accredited test is not conducted.
- v) Candidates must provide details with regard to the date of registration/date of joining, date of submission and date of award of degree for both M.Phil and Ph.D degrees, as the case may be, in the Application Form.
- vi) Candidates who are with M.Phil/Ph.D should mention against the column 'Academic Record' the name of the University/Institution and Guide/Co-Guide where and under whom they are pursuing/or have completed the M.Phil/Ph.D Degree.
- vii) Relevant grade which is regarded as equivalent of 55% wherever the grading system is followed by recognized university shall also be considered eligible.
- viii) Candidates who have been awarded post graduate/Ph.D degree from Foreign University should enclose "Equivalence Certificate" issued by Association of Indian Universities (AIU), New Delhi, without which their candidature will not be considered and Application Form will be rejected.
- ix) The appointment shall be governed by the rules and regulations of the University.
- University Grants Commission and the Union Ministry of Human Resource Development, whichever is applicable.
- xi) Applications of government servants should be sent through the administrative authority concerned and by the University employees through the Registrar of the respective Universities. Applications not routed through the respective channels are liable to be rejected. Candidates may send advance copy of the application along-with the requisite fee before the last date of receipt of application forms.
- xii) The University reserves the right not to fill any of the vacancies advertised, if Circumstance so warrant, without assigning any reason thereof.
- xiii) The number of vacancies indicated in Advertisement Notice is tentative. The University reserves the right to increase/decrease the number of posts at the time of selection.
- xiv) Only those candidates should apply for the post/s, who fulfil all the eligibility criteria by the last date laid down in the advertisement notice by the University.
- xv) The period of time taken by the candidate to acquire M.Phil and /or Ph.D Degree shall not be considered as teaching / research experience to be claimed by applicant to the teaching positions.

#### J) GENERAL INSTRUCTIONS:

- i) Candidates shall be asked to produce the original documents relating to their age,
- qualifications, experience, fitness and other claims whatsoever at any time during the selection process.
- ii) Candidates invited for interview shall not be paid any TA and DA.
